### Introduction

The Wingellina Project will have impacts on local people. Nico wants to understand the impacts and create opportunities from the Wingellina Project. In 2012, the people were consulted, and a Social Plan was written.

### Ara kuranyutjanya

Irrunytju apuku tjawantjangku Anangku life, panya nyinanytjanya kutjupananyi.

Nico-ngku, panya apuku tjawalpaingku tjapini, "Yaaltji-yaaltji Irrunytju Anangku life, panya nyinanytja kutjuparringkuku." Munu kutjupa tjana mukuringanyi kulintjikitja ara tjutanya panya wiru Tjuta ngaratjunkunytjaku Irrunytju apu tjawantjanguru.

Miitingi nyura kanyinu 2012-angka, miitingi nyara-palula, nyurampa Anangu tjutaku Social Plan-a write-amilanu.

**Social Plan 2012** There were discussions about the development of the Wingellina mine with the Traditional Owners on country and by phone. Those consulted were: Wingellina residents; service providers; residents in Pipalyatjara, Kalka, Blackstone; Ng Council, Ng Services, Ng Health, NATS); State and Local government and Employment Training Services.

### 2012 Social Plan

Irrunytju mine/apu tjawantjaku tjapira kuliningi nguratitja tjutanya telephone-angka munu *on country* miitingingka.

Anangu nyanga-tjalalakutu, tjana wangkangu: Irrunytju Anangungka, Pipalyatjara Anangungka, Kalka Anangungka, Blackstone Anangungka.

Munu tjana wangkangu Ngaanyatjarra Council warkipai tjutakutu, Ngaanyatjarra Health warkipai tjutakutu, Ngaanyatjarra Agency munu Transport Services warkipaikutu munu Kapaman warka training palyalpai tjutakutu.

### What did the stakeholders say in 2012?

The most important topics in 2012 were heritage and culture, followed by environment, training and employment and Aboriginal business development..

### Tjana uwankarangku miitingingka nyaa wangkangu 2012-angka?

Wangka pulka mulapa tjana uwankarangku Wangkangu panya kaltjatjara, heritage-atjara, nguratjara, training-atjara, warkatjara munu Anangku business Tjuta pakaltjunkunytjaku.

### Community & Mine Relations

#### Kumuniti munu Mine tjungu nyinantjaku munu tjungu warkaringkuntjaku.

2012-angka Anangu Kumunitinguru Tjuta-ara pitjapai alpaku, warkaku munu ngunti panya visit-ku.

Mine warkana tjuta mulapa nyinara warkaringku-nyangka utiringkupai kura tjuta. Nyanga palurungku kurani panya uwankara wirura tjungu nyinara munu uwankara wirura tjungu warkaringkuntjaku.

Irrunytju mine ma-pakani ka nyara palulangu Tjungungku Anangungku munu mine Warkanangku rawangku nyakuku (check-amilalku) panya uwankara nyinantjanya munu warkaringkuntjanya

**Response** The 2012 Social Plan has a list of actions to manage impacts and create opportunities. Most actions will happen during construction, or during operation of the Project. Here are some examples.

### Wangka pakantja

2012 Social Plan-tu warka tjuta kanyini palyantjaku munu titutjarangku warka tjutanya nyakutinytjaku munu panya kuraringkula kutjuparingkunyangka wirura tjukaruruntjaku. Munu kutjupa panya kulira, nyakula wiru tjuta pakaltjingara ngaratjunkuntjaku.

Warka nyangatjananya utiringkuku mine build-amilara ngaratjunku-nyangka, munu tjinguru mine-ta tjararingkula tjawan-nyangka. Tjaru read-amilara nyawa, warka palyantjaku Irrunytju mineku:

- 1 Implement a Cultural Heritage Management Plan to ensure access and protection of cemetery and heritage sites.
  - Ultja munu kaltja witira wirura kanyintjaku Plan piipangka tjunanyi. Panya ngura Ananguku Ultjatjara, kaltjatjara munu cemetarynya atunymankula kanyintjaku.
- 2 Implement a Workforce Plan including rules for behaviour after hours, travel and driving, community interaction, drug and alcohol testing.
  - Plan piipangka write-amilara tjunanyi panya yaaltji-yaaltji warkana tjutanya mine-ta wirura warkaringkuntjaku. Rules piipa plan nyangangka tjunanyi, yaaltji-yaaltji warkana tjuta wirura nyinantjaku munu para-ngarantjku warka wiyaringku Ananguku Land-angka, yaaltji-yaaltji tjana iwarangku para-ngarantjaku wirura panya trouble kutjupa-kutjupa palyantjawiyangku. Kutjupa miners tjuta yaaltji-yaaltji wirura nyinara, warkaringkuntjaku Ananguku Land-angka. Kutjupa ngaraku mine warkana tjutaku panya drug munu wama test tjanampa palyani kalala Tjuta-ara.
- 3 Develop an Aboriginal Employment Plan
  - Plan piipangka write-amilani panya warka tjutatjarra, Anangu tjutangku palyantjaku mine-ta munu ngurangka.
- 4 Implement an Environmental Management Plan
  - Plan piipangka write-amilani panya ngura/Ananguku land wirura atunymankuntjaku.
- 5 Provide 4 traineeships and employ at least 10 Aboriginal workers.
  - 4 Anangu traineeship tjunanyi tjana 4 Anangungku training warka palyara warkaringkuntjaku mine-ta.
- 6 Cultural awareness training to be taught by Ng Lands person for workers.
  - Ananguku kaltja nintinma mine warkana tjutaku, training nyangatja Ngaanyatjarra Lands Anangungku palyantjaku.
- 7 Have a team of men and women Aboriginal employees to act as heritage monitors
  - Anangu wati munu minyma tjunanyi warka palyantjaku ulytjaku (heritage-ku) munu titutjarangku nyakukatintjaku.
- 8 Implement a traffic management plan and traffic awareness training.
  - Plan piipangka write-amilani mine-kutu mutuka, taraka munu kutjupa ankupayitjara iwarangka. Piruku Anangu munu mine-ta warkipai tjutanya nintini, train-amilani iwarangka wirura safe way para-pitjantjaku.
- 9 Have 2 mine tours each year for local people.
  - Yiya kutjungka, tour kutjara ngaratjunanyi, panya Anangu Tjuta para-katira mine nintini.
- 10 Sponsor sports teams, volunteering and local events, as requested by the community
  - Ngaanyatjara Lands kumunitingku tjimariku tjapin-nyangka unganyi, panya sports-aku, festival-aku munu kutjupa-kutjupaku.
- 11 Provide Ng Council information about contracting and business opportunities.
  - Ngaanyatjara Council-anja tjakultjunanyi contracts warkatjara munu business warkatjara
- 12 Try to get money from government for training and employment of Ng Lands People
  - Tjimariku arkara kapamanta tjapini Ananguku munu Training-iku.
- 13 The mining agreement provides money for education and training.
  - Irrunytju mine-nguru tjimarri unganyi education-ku munu training-ku.
- 14 Establish a way to report concerns or complaints.
  - Piipangka write-amilani panya kura tjuta utiringanyi ka panya yaaltji-yaaltji kura (problem/complaints) nyara palunya wirura tjukaruruntjaku (fix-amilantjaku).

### What's Next in the Wingellina Social Plan Process

Today, some Project stakeholders are different to those of 2012, and it is important that they have their say too.

There will be more discussions and consultation during the next phase of project development, the Definitive Feasibility Study.

### Nyaa ngaranyi nyanganguru Irrunytju Social Plan-ku?

Kuvari Anangu munu organisation new-ana tjuta nyinanyi/ngaranyi munu tjanampa ngaranyi tjarpantjaku Irrunytju mine Plan new-wanangka. Wangka ngarmanypa wangkangu 2012 ka kuwarla 2024-ngka.

Kuwaringuru mitingi kutjupa tjuta ngaraku panya numpa tuu (two) para-pitjala Anangukutu munu organisations tjutakutu wangkantjaku. Nyanga palunya wangkanyi Definite Feasibility Study.



Waaka munu kutjupa-kutjupa ngula ngarantjaku

Yiya 2012-angka Anangu tjuta purkara mukuringangi ngura Irrunytjuku munu Ananguku tjukurtpaku (heritage-aku) munu kukaku ankupaiku munu mai putitjaku ankupaiku.

Ara nyanga tjananya Anangungku wangkangu kunpura wiruntjaku panya kumuniti-ngka waaka kupa ngarangi. Tjimirri tjuku-tjuku Anangungku mantjini munu panya kutjupa-kutjupa wiru tjuta ngarantjawiya Ananguku Kumunitingka.

Yiya 2012-angka, Anangu pulkara tjituru-tjituru wangkangi ngurra Irrunytjuku, panya wantira ankuntjikitjangku. Palu tjana wangkangu Irrunytjunya lipula ngaranytjaku ngurra Ngaanyatjarra Lands kumuniti tjuta purunyapa. Wiru tjuta ngaranyi utiringkuntjaku apu tjawantjanguru/mining-nguru. Palu Anangu tjutaku ngaranyi pulkara nintiringkula munu train-aringkuntjaku, panya mine-ta ninti waakaringkuntjaku.

### Future Prospects

In 2012 the community had a strong affection for Wingellina and the way of life including traditions, hunting and bush tucker.

However, they felt that the infrastructure was poorly maintained, incomes were low, and opportunities and service were limited.

In 2012, most people seemed to accept the relocation of the community and expressed 'sadness' about leaving their homes, (leaving behind hills and land). They expected that Wingellina should have services as other communities of the similar size and location.

There are opportunities for the community to benefit from mining. This requires increased education and training of residents.
